## **Funding**

The evaluation is funded through NEDC's core funding with the Federal Government, Department of Health and Aged Care.

## What is the purpose of the evaluation?

You are invited to participate in the evaluation of <u>NEDC's Training Approvals</u>. We hope to learn about training providers' experience of applying for approval of their training. In particular, we are interested in learning whether the Training Approval process is efficient for the applicant/training provider and whether the Training Framework and Training Approvals has impacted on the quality and accessibility of the training. We are also interested in the impact that the NEDC Training Approvals may have had on upskilling the workforce in Australia.

## Who is being asked to participate?

Training providers that have applied for approval of their training through NEDC's training approvals. This includes trainings that have or have not been approved.

### Do I have to participate?

Participation in the NEDC Training Approvals Evaluation is voluntary. If you want to be part of the evaluation, we ask that you read the information below carefully.

You can read the information below and decide at the end if you do not want to participate. Non-participation will not affect your relationship with NEDC or any other listed organisation.

## What does taking part involve?

If you decide to take part in the NEDC Training Approvals Evaluation, you will be asked to complete an online survey.

The survey will ask you about:

- Your profession
- Your experience of applying for approval of your training
- Your feedback to change or improve the approval process
- Your perspective on the impact of the Training Approvals on your training and on training across Australia

No personal identifiable information will be collected.

The survey will take approximately 10 minutes to complete. There will be one survey to complete in total.

#### What are the benefits?

Although there is no direct benefit to participants, information from the survey will assist NEDC to improve the Training Approvals process for future applications and renewals. Information can also be used to drive future workforce development initiatives, as aligned with the <a href="National Eating Disorders">National Eating Disorders</a> Strategy 2023-2033.

#### What are the risks?

With any study there are (1) risks we know about, (2) risks we don't know about, and (3) risks we don't expect. If you experience something that you aren't sure about, please contact us immediately so we can discuss the best way to manage your concerns.

This evaluation survey has been assessed as involving low or negligible risk to participants.

## Your right to protect yourself from harm and to seek support.

## What will happen to my information?

By clicking on 'I have read the Participant Information Form and consent to participate in this evaluation', you are agreeing to take part in the evaluation of *NEDC's Training Approvals*.

We will **collect** information about you in ways that may identify you.

We will **store** information about you in ways that will not identify you.

We will **report** and **publish** information about you in ways that will not identify you. For example, in a publicly available evaluation report or presentation at a conference using de-identified group data.

We will keep your information for 5 years or until we no longer need it after the project is completed. After this time, we will destroy all your data. In addition, we will take reasonable steps to destroy or deidentify your information when we have been directly instructed by you to permanently remove or suppress your information.

The storage, transfer and destruction of your data will be undertaken in accordance with the <u>Butterfly Foundation Privacy Policy</u>. Your information will be stored electronically on a secure, password-protected OneDrive only accessible by the approved research staff.

The personal information you provide will be handled in accordance with the Privacy Act 1988 (Cth) (Privacy Act), the Privacy and Data Protection Act 2014 (Vic) and other relevant Australian and state laws in relation to the management of personal information.

You have the right to access personal information about you and the right to request correction and amendment of it. NEDC will share a summary of the findings from the evaluation at the request of the participants and provide an opportunity for feedback.

## Will I hear about the results of the study?

We will let you know about the results of the study through a direct email to all training providers that have submitted an application for approval of their training.

Data may also be presented at scientific conferences.

## What if I change my mind?

If you no longer want to complete the questionnaire, simply close the web browser. If you change your mind after clicking on the 'Submit' button, we can only withdraw your responses if we can link who you are with your questionnaire responses (i.e., completed the items that state your name and/or email).

Your decision to withdraw at any point will **not** affect your relationship with NEDC or any other organisation listed.
